

# KEY PROCESSING DATES FOR CA-7/7A

**Fax # 513-684-5353**

Which date you use when signing a CA-7 form is important. The chart below tells you the earliest date that you can submit a CA-7 form to the injury compensation office.

**Ecomp is the preferred method to submit your CA-7/7a's-Make sure your forms have a current date on the signature line**

Untimely forms could delay your check. **Forms that are back-dated could result in a delay of processing.**
